Excavation Permit Application



The City of North Branch requires that all contractors making excavations on public property receive an excavation permit. The purpose of this permit is to assure the City of adequate notification to excavation, proper safeguards, adequate inspection, proper restoration and indemnification. The following information is required so that all excavations can be cataloged and retired upon satisfactory warranty periods.

Excavation Contractors must be a licensed excavator with the City of North Branch to obtain a permit. (No work allowed prior to permit being approved)

It is agreed that no work in connection with this application will be started until the application is approved and the permit is issued. It is further understood that this permit is issued subject to the approval of local city, village or borough authorities having joint supervision over said street or highway and subject to applicant's compliance with the rules and regulations of the Minnesota Environmental Quality Board and any other affected governmental agencies.

Furthermore, except for negligent acts of the city, its agents and employees, the utility companies and contractor(s) shall assume all liability for, and save the city, its agents and employees, harmless from, and all claims for damages, actions or causes of action arising out of the work to be done herein and the continuing usage, constructing, reconstructing, maintaining, and using of said utility/miscellaneous work under this application and permit of construction.
