## ORDINANCE NO. 237-16

AN ORDINANCE AMENDING THE NORTH BRANCH CITY CODE, CHAPTER 2, ADMINISTRATION; ARTICLE V, BOARDS, COMMITTEES AND COMMISSIONS RELATING TO TERM OF OFFICE.

THE NORTH BRANCH, MINNESOTA CITY COUNCIL ORDAINS:

### **SECTION 1 AMENDMENTS**

The following amendments are made to various Divisions of Chapter 2 of the City Code:

#### ***DIVISION 2. - ECONOMIC DEVELOPMENT AUTHORITY***

##### ***Sec. 2.153. Term of Office***

Appointments by the Mayor and approved by the Council shall be made at its last meeting in December. Appointees shall serve six-year staggered terms. One or more members' terms will expire annually. ~~Upon expiration of a term, the appointee shall continue until reappointed or a successor is appointed. In the event of any vacancy, the City Council shall appoint a person to complete the unexpired term. A vacancy must be filled in the same manner in which the original appointment was made.~~

#### ***DIVISION 3. - PARKS, TRAILS AND OPEN SPACE ADVISORY COMMISSION***

##### ***Sec. 2-179. - Term of office.***

Appointments by the city council shall be made at its last meeting in December. Appointees shall serve staggered three-year terms. One or more members' terms will expire annually. Terms shall commence on January 1 of the year of appointment. ~~Upon expiration of a term, the appointee shall continue until reappointed or a successor is appointed.~~ In the event of any vacancy the city council shall appoint a person to complete the unexpired term.

#### ***DIVISION 4. - PLANNING COMMISSION***

##### ***Sec. 2-209. Term of Office.***

Appointments by the city council shall be made at its last meeting in December. Appointees shall serve three-year staggered terms. One or more members' terms will expire annually. ~~Upon expiration of a term, the appointee shall continue until reappointed or a successor is appointed.~~ In the event of any vacancy, the City Council shall appoint a person to complete the unexpired term.

**DIVISION 5. - PUBLIC UTILITIES COMMISSION**

**Sec. 2-231. Terms of Office.**

Appointment by the city council shall be made at its last meeting in December. Appointees shall serve three-year terms. One member shall be appointed each year.

~~Upon expiration of a term, the appointee shall continue until reappointed or a success is appointed.~~ In the event of any vacancy, the city council shall appoint a person to complete the unexpired term.

**SECTION 2 EFFECTIVE DATE**

This Ordinance shall take full effect and be in full force from and after its passage and publication according to law.
