# 6.1 Park Dedication Fund

Sondrol reported the current fund balances.

Sondrol provided the latest project updates for the Commission.

### 8.3 Memorial Benches – Central Park

Sondrol provided an overview the North Branch Beautifications request to replace the existing benches in Central Park along Main Street with the new memorial bench.

Dahlberg felt that all the benches along Main Street should be replaced at the same time.

The following are the balances of the respective funds as of 4/1//15:

# Park Dedication Fund Balances:

Funds received through Park Dedication that can only be used for the acquisition and development of parks. The Park Dedication Fee is \$1800 per lot. The Park Dedication Fund receives \$1500 and Recreation Center receives \$300.

Recreation Center/Park Dedication Fund...\$46,362.74

### **Capital Improvement Fund Balances:**

Funds in the Capital Improvement Funds are generated through levies from tax payer dollars.

The City Council started to levy funds for the Library and Community Center in 2003 with the anticipation of constructing a library with community meeting rooms.

In 2003 the City Council also started levying funds for Park Improvements with the anticipation of not having to increase taxes for costs associated with a bond referendum for the completion of Williams and Wildridge Park or land acquisition. Both of These funds can be used at the discretion of the City Council.

Subject: NB American Legion – Veterans Memorial Park Proposal

**Background Information:** 

The North Branch American Legion Post 85 is conducting a study to determine the feasibility of establishing a Veterans Memorial Park within the city limits of North Branch. The Legion has informed the City that they have received positive feedback from the Clayton Anderson family about the possibility of obtaining a land donation for the park. The park would be named "Clayton Anderson Veterans Memorial Park". The vision of the park would be to display a military piece of equipment, a flag presentation and a plaque or series of plaques to honor members of the community that have served our country.

The final site has not been identified yet, however, ideally the site would be located in a highly visible location and the size of the site would not exceed one acre.

The Legion is requesting the City of North Branch to partner with them in this venture. Below are the proposed responsibilities of each entity.

The City's responsibility would be:

- Taking possession/ownership of the donated property
- Provide grass mowing and snow removal maintenance of the site

The Legion's responsibility would be:

- Conducting the fundraising for the site
- Acquisition of the site
- Establishing the display itself, access to the site, parking spaces
- Maintenance of the facilities (excluding grass mowing and snow removal)

The Legion has noted that it would be critical to establish a partnership with the City in order to move forward with establishing a Veterans Memorial Park.

Public Works noted that they would be conceptually in support of assisting with the mowing and snow removal for the proposed site. However they would want to review a formal site plan and develop a maintenance agreement prior to fully committing to the partnership.

# Other Pertinent Information:

- > Advantages: This would provide a tribute to honor veterans at little cost to the City.
- > 'Disadvantages: None

# Financial/Budget Impacts (If Any):

- > Funding Sources North Branch American Legion
- Long-Term & Short-Term Costs Minor Maintenance costs. To be determined based on selected site.

**Deadline:** The Legion would like to obtain an answer if the City is interested in forming a partnership ASAP to continue their efforts in moving forward.

# Requested Action & Staff Recommendation:

The requested is action is for the Commission to make a recommendation on the North Branch American Legion Post 85's request to partner with the City of North Branch on the development and maintenance of a Veterans Memorial Park.

Staff would recommend developing a legal agreement outlining roles and responsibilities if this is something City would like to move forward with.

Voting Requirements: State Law or City Code requires a simple majority, of those present.

# **Feasibility Study**

Commissioners,

North Branch American Legion Post 85 is conducting a study of the feasibility of establishing a Veteran's Memorial Park within the city limits of North Branch.

At this time we have received positive feedback from the Clayton Anderson family regarding donation of land for the above purpose. The memorial would be named the "Clayton Anderson Veteran's Memorial Park".

We are requesting the City of North Branch to be a partner in this venture with its portion being, taking possession of the donated piece of property, and to maintain the site with grass mowing and snow plowing services. At this time we have not settled on a final site, but we wouldn't expect the size of the area to maintain to be in excess of one acre.

The costs of establishing the display itself, access, and parking spaces, along with maintenance of the site, with the aforementioned exceptions, would be the responsibility of the North Branch American Legion. Our vision for the display is to incorporate a military piece of equipment, a flag presentation, and a plaque or series of plaques.

A successful fundraising campaign would be required to make this dream a possibility. It is our goal to honor members of our community that have served our country, and in some cases have paid the ultimate price.

Having the City of North Branch as a willing partner in this endeavor is critical. Please pass along your recommendation to the city council for further review and guidance in this matter.


